### Gloucestershire Vintage & Country Extravaganza 2026 General Summary Conditions of Entry

The Gloucestershire Vintage & Country Extravaganza is hosted by the Stroud Vintage Transport & Engine Club (SVTEC). By signing the declaration on an entry form, exhibitors are confirming that they have read, understood, and agreed to abide by our **full** terms and conditions of entry.

Failure to comply with our **full terms & conditions** may result in refusal of entry to, or ejection from the showground by event staff. In all cases the SVTEC Rally Manager's decision will be final.

- Entry forms must be **received by SVTEC by 1<sup>st</sup> June**, *we reserve the right to reject entries received after this date.*
- Exhibits must be presented in a clean, complete, and safe condition. That will include any relevant protection against loss of fluids that can cause environmental damage.
- All exhibits must be adequately and correctly insured against loss and public liability.
- **If it is necessary to change an exhibit or vehicle, this must be notified to and accepted by the section leader in advance and before arrival.** Exhibit details must match what is shown on the entry pass.
- Where applications are made by persons under 18 years old, all forms must be countersigned by a responsible adult.
- The showground (including campsite and access roads) is covered by the Road Traffic Act therefore:
  - No person under the legal age shall ride, drive, or operate any vehicle or machinery.
  - Exhibitors must ensure all drivers are fully competent and qualified in law to handle the vehicle exhibited.
  - Road vehicles must be taxed and tested (if not exempt) in accordance with the regulations for that type of vehicle for road use.
  - No vehicle may run on Trade plates.
  - A maximum speed of 5 MPH shall apply to all exhibits moving around the showground.
  - When moving exhibits, drivers must take special care with regard to young children and pets.
- Under no circumstances will more than the designed number of persons be allowed to ride on/in any vehicle or engine.
- Exhibitors and exhibits will not be permitted on the showground before 12 noon on the Thursday before the show opens, or after 12 noon on the Monday after the show closes, without prior approval in writing.
- On days when the show is open to the public, all exhibits must be in display position on their respective sections by 10am and are not allowed to vacate the showground before 5pm.
- All passes must be clearly displayed on arrival, and available for inspection while the exhibit is on the showground. **No valid pass, no admittance, no arguments.**
- All exhibitors must check-in with their exhibiting section as soon as possible after arrival.  
*In addition, you may be requested to sign an attendance register each day.*
- No vehicles other than those with correct entry passes associated with the exhibit and exhibitor may enter the showground and campsite. Any additional vehicles must be parked off the showground.
- Only two adults (i.e. driver plus one) and up-to 3 children under 16 years of age are entitled to free event entry when accompanying an exhibit.
- No exhibit may be left running unattended.
- Under no circumstances are barbecues, fire pits or any form of open fire to be used on the showground.
- Where exhibitors are responsible for young children they must supervise and control them to ensure that they are not putting themselves and others at risk.
- Pets must be kept under control at all times, dogs must be kept on a lead and supervised. Do not leave pets unsupervised in enclosed spaces. Ensure you clean up after your pets.
- SVTEC will provide:
  - A Safety Officer who can be asked for advice and guidance whilst the event is open. If you witness anything you believe to be dangerous or unsafe, please report it to the site office or a member of the event team.
  - Such safety equipment as it considers necessary.

## **General Summary Conditions of Entry (continued...)**

- The Gloucestershire Vintage & Country Extravaganza is made possible by a team of volunteers who willingly give their time and talents to put the show on. Rudeness, abuse & aggression towards them, other exhibitors or members of the public will not be tolerated.

### **Camping Terms & Conditions**

- Only one unit of camping will be allowed per exhibitor entry.
- You may be refused access to the campsite if you bring different camping accommodation to that stated on your entry forms.
- No access to exhibitor campsite for new arrivals after 20.00 hours (earlier in poor visibility).
- Vehicles being used for camping accommodation, whether a bespoke motorhome or a van converted for camping, must be registered with the DVLA (V5) as a Camper Van or display a valid habitation certificate.
- There will be no mains water on-site that is fit for human consumption. However bottled drinking water will be available for sale on-site during the show.
- Bottled gas is dangerous and can cause fatal injuries if used incorrectly. Only use it in a well-ventilated area (not inside a tent) using equipment and fittings that comply with current safety standards.
- All electrical equipment must be installed to approved standards and protected by suitable circuit breakers.
- Privately owned generators (those not supplied by the event organisers) **MUST**:
  - Be suitably earthed.
  - Be turned off between 10pm and 6:30am.
  - Not cause excessive radio interference.
